MAGISTRATE'S ORDER

This matter came before the Court for a status conference on Plaintiff's Complaint for Allocation of Parental Rights and Responsibilities. Plaintiff appeared and was not represented by counsel. Defendant did not appear. Service was attempted on Defendant at her last known address and was returned "return to sender, attempted- not known, unable to forward."

Plaintiff testified he does not know Defendant's current whereabouts. Her last known address to him was the Pennsylvania address in which the mail was returned. This is the address he retrieved the minor child from Defendant last summer. Plaintiff states he has had some, albeit sporadic contact with Defendant through Facebook; however Defendant has refused to state her location to Plaintiff. Furthermore, she has refused to tell the child where she is residing. Plaintiff said his best guess is New Jersey "in the streets."

Therefore, the Court makes the following orders:

- 1. Defendant shall be served by posting. The Clerk is ordered to post the complaint, summons, and all other orders and/or documents filed in this matter for Defendant.
 - 2. This matter shall be set for final hearing by separate order.
