7. Defendant's residence cannot be ascertained with reasonable diligence.





TO THE CLERK:

1. Post copies of the Custody Complaint, Summons, Affidavit in Support of Temporary Custody, Parenting Proceeding Affidavit, Notice of Final Hearing, and Notice of Posting upon Defendant, John Doe, the father of Arianna Thompson, DOB 09/03/15 on the Pickaway County Juvenile Court website, in the section designated as "Public Notices".
2. The notice shall contain the name and address of the court, the case number, the name of the first party on each side, and the name and last known address of, if any, of the person or persons whose residence is unknown. The notice shall contain a summary statement of the object of the complaint; the demand for relief; and shall notify the person to be served that he or she is required to answer within twenty-eight (28) days after the last date of posting.
3. This notice shall be posted for six (6) consecutive weeks.
4. The clerk shall also cause the complaint and summons to be mailed by ordinary mail, address correction requested, the person's last known address. The clerk shall obtain a certificate of mailing from the USPS. If the clerk is

notified of a corrected or forwarding address within the six-week period that notice is posted, the clerk shall cause the complaint and summons to be mailed to the corrected or forwarding address. The clerk shall note the name, address, and date of each mailing in the docket.

5. After the last week of posting, the clerk shall note on the docket where and when notice is posted. Service shall be complete upon the entry of posting.


Defendant is required to file an answer within twenty-eight (28) days of publication.
